Please note the following important information:

- Children are eligible to start Pre-school from the age of **two years and nine months**, subject to **place availability** and **staffing ratios**. In some cases, the Pre-school may defer a start date until the child is **three years old**, depending on these factors.
- As part of our transition process, every child will take part in a **home visit** and a **one-hour stay & play session** before starting. These sessions help your child feel comfortable and confident in our setting.
- A **one-off administration fee of £35** applies to all new starters. This supports a smooth and welcoming transition and includes:
 - A home visit
 - A one-hour stay & play session
 - A book bag
 - A personalised wooden name registration tag
 This fee is **non-refundable** and should be paid **before your child's start date**.
- All children will receive a home visit and stay & play session as part of their introduction. For families accessing fully funded places only, where payment of the fee is not made, your child's start date may be adjusted to enable us to deliver the induction sessions on days when the setting is closed to children. This ensures the smooth delivery of these sessions without affecting the running of the pre-school. This does not affect your child's place or funded entitlement.
- Invoices** are issued at the beginning of each month, and **payment is due within 14 days**. Fees begin **the day after your child's stay & play session**. Charges still apply if your child is absent. **Timely payment is required to secure and retain your child's place** at Houghton & Wyton Pre-school. The Pre-school offers **government-funded childcare places** for eligible 2-, 3-, and 4-year-olds. Where funding is not received, standard fees apply. Please note that **late payments may incur a penalty** in line with our fees policy.
